PROPOSED ORDINANCE

FIRE HAZARDS

It shall be the duty of the owner or lessee of every store, dwelling or other building, to keep such store, dwelling or other building, with all of its appurtenances, including the space not occupied by buildings, clear and free from all kinds of inflammable refuse or rubbish, or refuse or rubbish that is easily ignited.

It shall be the duty of the fire commissioners of any fire district within the Town, and in the eventthere are no fire commissioners, the Chief of Police, to inspect and examine any building, structure or premises for the purpose of determining whether there exists therein a fire hazard, and such fire commissioners, or chief of police, shall have the power to compel the owner thereof to remedy any conditions found to be a fire hazard.

Every person violating the provisions of this ordinance shall be punishable by a fine of not less than Five Dollars (\$5.00) nor more than Fifty dollars (\$50.00) for each offense. Each weeks continual violation of this ordinance shall consitutue a separate additional violation.

WHEREAS, the Town of Cheektowaga is a Town of the First class, and under the provisions of existing laws there is no person who can be appointed to execute the civil process issued by the fourts of the Town, except a Town policeman, whose time is fully occupied in performing his usual police duties; and

WHEREAS, the Board of Supervisors of Erie County has, upon application of the Town of Amherst, granted authority to its Town Board to appoint constables under the recent amendment to the Town Law;

BE IT RESOLVED, that the Town Board of the Town of Cheektowaga hereby requests the Board of Supervisors of the County of Erie to provide by resolution the necessary authority to the Town Board of the Town of Cheektowaga whereby it may, by its own resolution, appoint not to exceed two constables who shall be paid no salary, but who shall be entitled to collect the statutory fees allowed by law in civil actions and proceedings.

That a copy of this resolution be forwarded to the Board of Supervisors for appropriate action.

Supervisor Zalemski, moved as an amendment to table this resolution for further consideration and it was seconded by Councilman Burst,

The roll call on the amendment resulted as follows:-

Councilman Denk, Kaufman and Rzyrkowski, voted against the amendment, Supervisor Zalemski and Councilman Burst voted for the amendment.

Result 3 against, 2 for. The amendment was lost.

The Clerk then called the roll on the original resolution with a result of: Councilman Denk, Kaufman and Rzyrkowski voted for the resolution, Supervisor Zalemski and Councilman Burst voted against.

Result of vote: 3 for 2 against. The original resolution was carried.

Councilman Kaufman moved the following resolution and it was seconded by Councilman Rzyrkowski.

WHEREAS; there has been passed in the Senate an amendment to the Town Law reducing the number of the Justices of the Peace in the town of the first class to one Justice and an acting Justice: and,

WHEREAS, there are now three Justices in the Town of Cheektowaga and under the present law the number is reduced to two com

WHEREAS, this board feels that the decision as to how many justices are required in a Town of the first class should be made by the Town itself, either by action of the Town Board or by referendum; and

WHEREAS, the provisions of the Hewitt Bill No. 739, Int. 687, reduces the number of Justices of the Peace to one, without conferring any authority upon the Town itself to determine the number of Justices to be elected;

BE IT RESOLVED, that the Town Board of the Town of Cheektowaga go on record as opposed to the Hewitt Bill above mentioned in its present form; and

BE IT FURTHER RESOLVED, that the Town of Cheektowaga is not opposed to permissive legislation along the lines of the Hewitt Bill.

Carried, Ayes -5- Noes -0-

Moved by Councilman Denk, seconded by Councilman Kaufman that the following resolution be adopted:-

RESOLVED, that the Town Board of the Town of Gheektowaga recommend that the specifications for additions in sewer district No. 3 to amended to provide for the use of 3 foot pipe where practical, and that G.K. sewer compound be used to seal the joints.

Carried, Ayes -5- Noes -0-

On motion of Councilman Denk, Seconded by Councilman Rzyrkowski the following resolution was adopted:-

RESOLVED, that the Town Board recommend as a foreman in the construction of additions in sewer district No. 3, Arthur Heinold, Winkler Road, Cheektowaga, N.Y.

Carried, Ayes -3- Noes -0-Supervisor Zalemski and Councilman Burst, not voting.

Councilman Denk, offered the following resolution and moved its adoption and it was seconded by Councilman Kaufman.

- RESOLVED, that Victor Vieregg be authorized to procure compensation insurance at town expense severing employees of the Town, required by law to be covered by compensation insurance. The policy to be submitted to the Town Attorney for approval as to form.

Carried, Ayes -4- Noes -0-Supervisor Zalemski not foting.

Councilman Denk, offered the following resolution and moved its adoption and it was duly seconded by Councilman Rzyrkowski.

RESOLVED, that Edward Smith be authorized to procure for the Town of Cheektowaga, the following policies of insurance.

Fire insurance policy on Town Hall, Union and Broadway, Cheektowaga, N.Y. in the sum of \$100,000.00 and \$25,000.00 for furniture and fixtures therein, also

Liability policy covering public liability for Town Hall, garage, baseball diamond and private residence \$5,000.00 to \$10,000.00 limits and that the policies when written be submitted to the Town Attorney for approval as to form.

Carried, Ayes -4- Noes -0-Supervisor Zalemski not voting. On motion of Councilman Burst, seconded by Councilman Denk the Board adjourned.
