- E. Ad Valorem Budget Consultation Will read the tentative 2004 Ad Valorem Budget and report as to their observations and recommendations to the Supervisor and Town Board on that document. Will also provide commentary on the internally-prepared projections of available fund balances related to budget preparation (minimum 125 hours for D, E ad F combined).
- F. <u>Compilation of Detailed Budget Presentation Document</u> (minimum 125 hours for D, E and F combined).
- G. <u>Audit of Town Clerk, Tax Receiver and Town Justice Budgets</u>. Will compile financial statements for these departments on the cash basis of accounting.
